Context

The world is experiencing an unprecedented transition from predominantly rural to chiefly urban living. The share of the world's population living in urban areas is expected to increase to 66% by 2050, adding 2.5 billion people to the urban population, with about 90% of the increase concentrated in Asia and Africa. If left unchecked urban population growth can lead to vast unsustainable urban sprawl, or the creation of dense slums with poor living standards. Cities will need to accommodate more people without increasing their urban footprint; increasing density, without decreasing quality of life.



In an effort to pave a path towards more sustainable development, the UN agreed the Sustainable Development Goals with 193 Member States in September 2015, with the SDGs coming into effect in January 2016. In recognition of the importance of focusing on cities to achieve sustainable development, SDG 11 is specifically dedicated to cities and has the objective to "Make cities and human settlements inclusive, safe, resilient and sustainable".

However, it will be under the auspices of cities where we will succeed or fail in achieving the SDGs of poverty eradication, equality, climate change reduction, and ensuring healthy lives. It will be the cities that determine if we achieve inclusive economic growth or yield to greater inequality. It is in cities where people will seek opportunities for higher education and employment and it will be cities that determine if we will continue our steadily increasing usage of the world's resources or if we can realize a more sustainable path. In recognition of the role of cities, Mayors who were present at the historic agreement of the SDGs pledged to "play a defining role in embracing, endorsing, implementing, and monitoring these goals".

In October 2016, under UN Resolution 66/207, and in line with the bi-decennial cycle (1976, 1996 and 2016), the United Nations General Assembly convened the United Nations Conference on Housing and Sustainable Urban Development (Habitat III) in Quito, Ecuador, to reinvigorate the global commitment to sustainable urbanization over the next 20 years. 193 Member States agreed the New Urban Agenda outcome document, which will guide the next 20 years of efforts around sustainable urbanization. The New Urban Agenda has placed a particular emphasis on:

- 1. Urban Rules and Regulations
- 2. Urban Planning and Design
- 3. Municipal Finance

Mayors believe that in an increasingly urbanized world, cities and human settlements will be the key to achieving the implementation of the SDGs and the New Urban Agenda. However, if significant progress is to be made, national governments will need to find the political will to empower cities and assist them in building capacity and resources and cities will need to create the environment to enable vital cooperation between the public and private sector and wider civil society to create the financial and delivery models required to deliver sustainable development.

This one-hour session will bring together Ministers, Mayors, Business Leaders in the fields of infrastructure, urban development, energy, mobility, investment, health and ICT, Multilateral banks, Development Agencies and Civil Society to identify their collaborative role in the implementation of the SDGs and New Urban Agenda.

Session Purpose

The purpose of the 'Accelerating Progress on Urban Development' session is to provide an enabling platform for senior level representatives from business, national and city government and civil society to discuss how national and city governments can work more effectively to respond to the challenges of urbanization, and better coordinate efforts and resources to implement smart and sustainable urban development solutions over the next 20 years. In addition, it will enable cities and the private sector to discuss how to create the environment to enable vital cooperation between the public and private sector and wider civil society to create the financial and delivery models required to deliver sustainable urban development.

Objectives

• Create a trusted community of Ministers, Mayors, business leaders, leaders of international organizations and civil society, who can openly and effectively exchange ideas on sustainable urban development, with a particular emphasis on the implementing of the SDGs and New Urban Agenda.

• Debate the policies and actions required to address the challenges and opportunities brought by urbanization, with a particular focus on creating public private cooperation the governance, finance and design and build mechanisms required to deliver sustainable urban development.
