- 1) We have audited the financial statements of **INSTITUTO IGARAPÉ**, which comprises the Balance Sheet as of December 31st, 2013, and the related Statements of Income for the period, of Changes in Equity and Cash Flow for the year then ended, and a summary of significant accounting policies and other accompanying notes.

In this risk assessment, the auditor considers internal control relevant to the preparation and fair presentation of the Financial Statements of the company to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of internal controls company. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of accounting estimates made by management, as well as evaluating the overall presentation of the Financial Statements taken as a whole.
